

# **Privacy Notice**

## **Introduction**

Privacy and security are very important to us. This Privacy Notice is meant to help you understand how and why we at [CHIBAOCHENG LIMITED](“we”, “us”, or “our” ) collect, use, and share your data when you use our [Future Letter Moment](“App” or “Service”). You should read this Notice carefully, it contains important information about your privacy rights and choices.

## **What is the purpose for collecting personal information**

We collect personal information in order to:

- Provide you with the Service requested by you.
- Communicate with you about your use of the App.
- Operate, understand, develop and improve our App.
- Comply with our legal obligations.
- Ensure the safety and security of our users and the security of our property.

## **What information we collect**

We may receive the following information about you:

- email address.
- device identifiers (such as IDFA, IDFV for Android, GAID for IOS).
- the type, version, brand, language and operating system of device.
- the type and operator of network (such as Mac address).
- behavioral usage of the App.

## **How we share your information**

We may share information in the following ways:

- With our service providers. We may share information with vendors, consultants, and other service providers who need access to such information to carry out work for us.

- To comply with the law. We may share information if we believe disclosure is in accordance with, or required by, any applicable law, regulation, legal process, or governmental request.
- With our affiliates. We may share information with our parents, affiliates, subsidiaries, and other companies under common control and ownership.

### **What rights do you have**

You may have different rights in relation to your personal data:

- Right of access. You can ask us for copies of your personal data.
- Right to rectification. You can ask us to rectify information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.
- Right to erasure. You can ask us to erase your personal data in certain circumstances.
- Right to withdraw consent. Where we are relying on consent to process your personal data, you can withdraw it at any time. This will not affect the lawfulness of any processing carried out before you withdraw your consent.

### **How we protect your information**

Our security policies and practices are designed to protect the confidentiality and integrity of your data. We implement controls designed to limit access to this data to personnel who have a business reason to know it and prohibits its personnel from unlawfully accessing, using or disclosing this data.

### **How long will we store your information**

We will keep your personal data only for as long as necessary to fulfil the purposes for which we are processing your personal data unless the law permits or requires longer.

### **Children's policy**

Our App is not directed to individuals under 13 and we do not knowingly collect data relating to children.
